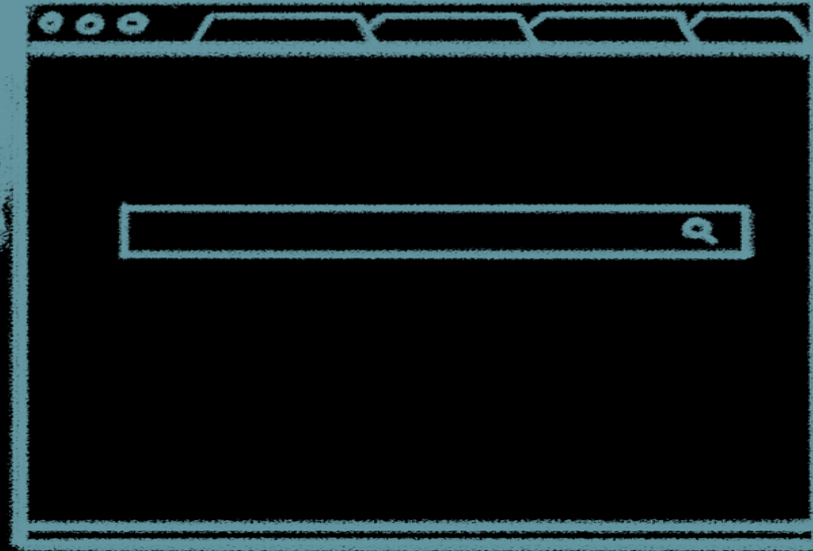
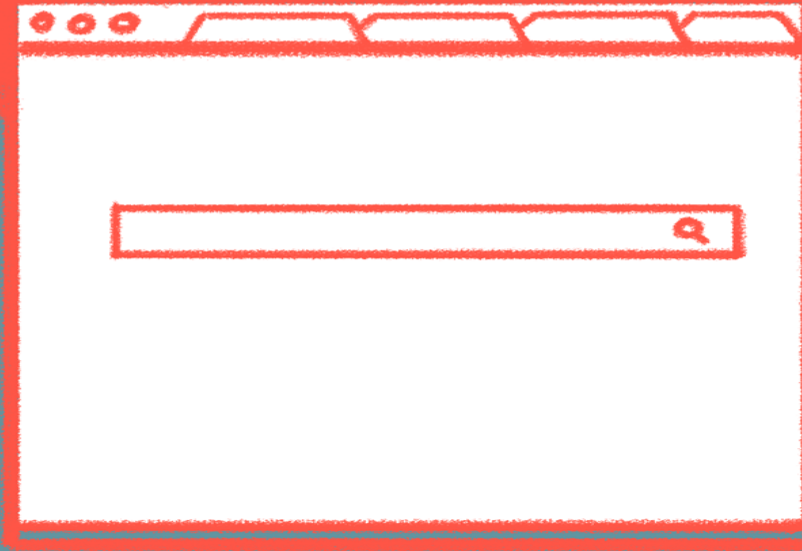


PERCENT OF WOMAN MISCATEGORIZED VS. PERCENT OF MEN MISCATEGORIZED
